**TECHNICAL WORKSHOP ON THE DEVELOPMENT OF ELECTRONIC TOOLS
FOR NATIONAL AUTHORITIES TO SUPPORT CWC DECLARATIONS
IN A COMMON ELECTRONIC FORMAT
THE HAGUE, THE NETHERLANDS, 18 - 19 SEPTEMBER 2000**

1. The Technical Secretariat (herein after the “Secretariat”) intends to develop a software package that will be made available to interested National Authorities to assist them in the preparation and submission of declaration data due under Article VI of the Chemical Weapons Convention. This software, which will be provided free of charge, will allow the submission of such data in a standardised print format as well as electronically. The software will allow users to export and import declaration data in an agreed common file format (the common transmission file structure, CTFS), and to print the data into the forms provided in the Declaration Handbook.
2. As part of this project, the Secretariat will convene a technical workshop for experts in data and information systems, as well as for the future users of the software package from interested States Parties. The workshop is scheduled to be held at the OPCW Headquarters in The Hague from 18 to 19 September 2000.
3. The purpose of the workshop is to review the current situation regarding the submission of declaration data in electronic form, to identify the detailed user requirements for a software package for National Authorities, and to discuss the next steps in this project. The provisional workshop programme is attached as annex 1 hereto.
4. The workshop will be conducted in English. No interpretation will be available, and all workshop materials will be provided only in English.
5. Interested States Parties that wish to contribute to the development of the software package are invited to send their experts to the workshop. Participants are requested to complete the registration form attached as annex 2 hereto, and to submit it to the International Cooperation and Assistance Division **by 31 August 2000 at the latest**. Sponsorship will not be available for this workshop; all participants will be expected to make their own travel and accommodation arrangements.
