AN INVITATION TO PARTICIPATE IN A REGIONAL WORKSHOP ON IMPLEMENTING LEGISLATION AND INTERNATIONAL COOPERATION ISSUES MBABANE, SWAZILAND, 28 - 30 NOVEMBER 2000

- 1. The Government of Swaziland and the Technical Secretariat of the OPCW (hereinafter the "Secretariat") invite representatives of States Parties and signatory States to the Chemical Weapons Convention (CWC) from the Southern African Development Conference (SADC) region to attend a workshop on the implementation of the CWC. This workshop, which will focus on national implementing legislation, international cooperation issues, and the CWC's provisions for monitoring transfers of scheduled chemicals, will be held in Mbabane, Swaziland, from 28 to 30 November 2000.
- 2. When this invitation was published, Angola an SADC member had not yet joined the CWC. Should Angola wish to be represented at the workshop, it will accordingly be obliged to make its own arrangements. Attendance by representatives of Angola would enable its Government to be informed at first hand about the CWC and to learn about the benefits of membership of the OPCW.
- 3. The workshop will provide a forum in which government officials, particularly those responsible for drafting or proposing amendments to CWC implementing legislation, can pool their experiences with a view to adopting the most efficient strategies for preparing the legislative/regulatory framework for implementing the Chemical Weapons Convention. Each invited State Party is requested to nominate up to two candidates (one representative of its National Authority, preferably with a good understanding of its chemical industry, and one expert in the drafting of legislation).
- 4. The provisional programme of the workshop is contained in annex 1 to this invitation. The workshop will be conducted in English only. Due to a lack of funding, no interpretation services can be provided.

- 5. As part of the preparations for the workshop, each National Authority is requested to provide a brief written summary of the following: (a) national legislation and regulations currently in force on chemicals and what they provide for, or do not provide for, in relation to the CWC; and (b) national legislation and regulations on chemicals that are currently being drafted, if any. Delegations will also be expected to present one to two pages of project proposals for discussion at the workshop, in order to assist the Secretariat to draw up an OPCW regional programme which meets the needs of the region.
- 6. As has been pointed out above, the Secretariat will be able to sponsor up to two representatives of the National Authority or other government agencies of each State Party. The sponsorship will cover the costs of international travel for and accommodation during the workshop, in accordance with the standard OPCW procedures and rates. Details of the OPCW's terms and conditions for the sponsorship of participants will be provided separately to the participants through the Swaziland National Authority, which is responsible for contacting the respective National Authorities about these matters.
- 7. Participants nominated by their governments or by National Authorities, or any other prospective participants able to pay privately for their participation, are invited to complete the registration form contained in annex 2 to this invitation, and to return it to the Secretariat **no later than 30 September 2000**, together with an indication of whether OPCW sponsorship is a precondition for their participation.
