# NOTE BY THE DIRECTOR-GENERAL

# WORKSHOP ON THE CHEMICAL WEAPONS CONVENTION ADDIS ABABA, ETHIOPIA 6 – 7 OCTOBER 2005

- 1. On behalf of the Organisation for the Prohibition of Chemical Weapons (OPCW), the Director-General is pleased to invite States Parties and States not Party in Africa to a workshop on the universality of the Chemical Weapons Convention (hereinafter "the Convention"), to be co-organised with the African Union (AU), and to be held at the Headquarters of the AU Commission in Addis Ababa, Ethiopia, from 6 to 7 October 2005.
- 2. The workshop is being organised in close collaboration with the AU Commission, and will focus on addressing the challenges African States not Party face in joining the Convention. The workshop will also provide an opportunity for the Technical Secretariat (hereinafter "the Secretariat") of the OPCW and the AU Commission to strengthen their cooperation within the framework of AU decision AHG/Dec. 181 (XXXVIII) on the Chemical Weapons Convention (hereinafter "the Convention"), which was adopted by the 38th Ordinary Session of the Assembly of Heads of State and Government of the Organisation of African Unity, which took place in Durban in July 2002. A copy of that decision is annexed hereto.
- 3. The workshop, supported by the European Union (EU) in accordance with the joint action: "EU Support for OPCW activities in the framework of the implementation of the EU Strategy against Proliferation of Weapons of Mass Destruction", is intended to help increase awareness of the Convention amongst African States. The objectives of the workshop are to further sensitise States not Party to the benefits of adherence to the Convention, to promote the universality of the Convention and to contribute to its full and uniform implementation in Africa. In addition, the workshop will provide a forum for participants to exchange information on their experiences and best practices, and will stimulate a dialogue between States Parties and States not Party to the Convention.
- 4. The two-day workshop will include a number of elements:
  - (a) a review of the Convention and its basic obligations;
  - (b) a presentation on the status of the implementation of the Convention in Africa;

- (c) a discussion of problems that commonly arise as Member States seek to fully and uniformly comply with the Convention's obligations;
- (d) a discussion of practical measures that can help achieve the goal of full compliance; and
- (e) information sessions on the Convention tailored to the needs of signatory and non-signatory States.
- 5. The workshop will emphasise the benefits of adhering to the Convention from the standpoint of international cooperation, and will include segments on the OPCW's international cooperation, protection, and assistance programmes. The provisional programme for the workshop is contained in Annex 1 to this Note.
- 6. In order for the specific needs of individual States to be met, adequate time will be reserved for bilateral consultations, which will provide an opportunity for discussions to take place on the status of preparations in individual countries for joining and implementing the Convention, and on the kinds of assistance or support that are required. Participants are requested to indicate their interest in such discussions when submitting their applications, so that these consultations can be planned in advance.
- 7. The Secretariat will sponsor the participation of representatives of African States not Party. Each nomination should specify whether sponsorship is a condition of the nominee's participation. For sponsored participants, the Secretariat will cover the costs of travel, meals, and medical insurance, and will provide a limited subsistence allowance to cover sundry expenses. In cases where the Secretariat arranges accommodation for sponsored participants, it will also cover the costs of that accommodation. Sponsored participants who do not intend to use the accommodation provided by the Secretariat are requested to indicate that to the Secretariat as soon as possible, so that it does not incur hotel cancellation fees. The daily subsistence allowance will remain unchanged for those participants who opt to make their own accommodation arrangements. States Parties are encouraged to bear the costs associated with sending representatives to the workshop.
- 8. When making travel arrangements for sponsored participants, the Secretariat will seek the most economical options. The Secretariat will purchase tickets and send them to participants. Sponsored participants will be allowed to purchase tickets locally only if this leads to further savings for the Secretariat and if the Secretariat authorises it. In order for the Secretariat to keep costs to a minimum, sponsored participants are expected to arrive **no earlier than 5 October 2005**, and to depart **no later than 8 October 2005**. The Secretariat will not cover expenses unrelated to the workshop or that result from changes to travel arrangements it has not authorised. Sponsored participants shall bear all costs resulting from changes they make, including cancellations, once the Secretariat has purchased their tickets. Participants who have not been sponsored are requested to make their own travel and accommodation arrangements, although the Secretariat can, if requested, arrange accommodation at reduced rates.

- 9. All proceedings will be conducted in English, and French interpretation services will be provided throughout. All participants must therefore possess a good command of one of these languages, as interpretation will be available simultaneously in English and French only.
- 10. Participants are requested to obtain any necessary visas (including transit visas) before travelling to Ethiopia.
- 11. States Parties and States not Party in Africa are invited to complete the nomination form that is included as Annex 2 to this Note, making sure to provide all the details it requests so that the Secretariat can contact nominees directly. Please be advised that participants must present an OPCW acceptance letter in order to register at the workshop.

## Annex 3

#### African Union Decision on the Implementation and Universality of the Convention on the Prohibition of the Development, Production, Stockpiling and Use of Chemical Weapons and on their Destruction

## AHG/Dec. 181 (XXXVIII)

## The Assembly:

1. **TAKES NOTE** of the Convention on the Prohibition of the Development, Production, Stockpiling and Use of Chemical Weapons and on their Destruction (hereinafter the Convention) that aims to achieve the effective prohibition of the development, production, acquisition, transfer, stockpiling and use of chemical weapons and their destruction,

2. **RECALLS** United Nations General Assembly Resolution A/RES/55/33 of 20 November 2000 which notes with appreciation the ongoing work to achieve the objective and purpose of the Convention, to ensure the full implementation of its provisions and to provide a forum for consultation and cooperation among States Parties,

3. ALSO RECALLS the steadfast position of Africa regarding Weapons of Mass Destruction and in particular to the Pelindaba Treaty,

4. **ACKNOWLEDGES** the conclusions and recommendations of the workshop devoted to Africa on the Chemical Weapons Convention held in Khartoum, the Sudan, from 9 to 11 March 2002,

5. **WELCOMES** the recommendation for an effective implementation of the Chemical Weapons Convention in Africa through sustained technical assistance from the Technical Secretariat of the Organisation for the Prohibition of Chemical Weapons,

6. **ENCOURAGES** the call to achieve universality of the Chemical Weapons Convention in Africa,

7. **REQUESTS** the Secretary General to inform Council, at its regular sessions, of developments regarding the implementation of the Chemical Weapons Convention and the progress made on the issue of universality.
