مذكرة من المدير العام

قائمة بنصوص التشريعات التي قدمتها الدول الأطراف بموجب الفقرة ٥ من المادة السابعة من اتفاقية الأسلحة الكيميائية

- ١- تقضي الفقرة ٥ من المادة السابعة من اتفاقية الأسلحة الكيميائية ("الاتفاقية") بأن تقوم الدولة الطرف بإعلام منظمة حظر الأسلحة الكيميائية ("المنظمة") بالتدابير التشريعية والإدارية التي اتخذتها تنفيذاً للاتفاقية.
- ٢- وخلال الدورة الاستثنائية الأولى لمؤتمر الدول الأطراف لاستعراض سير العمل باتفاقية الأسلحة الكيميائية، التي عُقدت في عام ٢٠٠٣، طلب مؤتمر الدول الأطراف ("المؤتمر") من الدول الأطراف أن تقدّم إلى المنظمة النص الكامل لتشريعاتها الخاصة بتنفيذ الاتفاقية على الصعيد الوطني وبما فيه تحييناته، أو معلومات عن التدابير المحددة التي اتخذتها الدولة الطرف المعنية لتنفيذ الاتفاقية إذا كان نظامها القانوني واحدياً (الفقرة الفرعية ٧-٨٣ (ج) من الوثيقة RC-1/5 المؤرخة بـ ٩ أيار/مايو ٢٠٠٣). واعتمد المؤتمر في دورته الثامنة خطة العمل الخاصة بتنفيذ الالتزامات بموجب المادة السابعة من الاتفاقية، التي أعرب فيها عن اتفاقه على أنه لا بد للدول الأطراف التي لمّا تفعل ذلك من أن تقوم بهذه الخطوة (الفقرة الفرعية ١٤ (ج) من الوثيقة C-8/DEC.16 المؤرخة بـ ٢٤ تشرين الأول/أكتوبر ٢٠٠٣).
- ٣- وترد في الملحق بالمذكرة الحالية قائمة بما قدمته الدول الأطراف إلى المنظمة من نصوص التشريعات الخاصة بتنفيذ الاتفاقية على الصعيد الوطني.



٤- كما إنه تم إدراج النصوص المتلقاة في شكل إلكتروني ضمن قاعدة البيانات الخاصة بالتشريعات، المتاحة على موقع المنظمة على شبكة الإنترنت www.opcw.org^١. وقد غدت قاعدة البيانات الخاصة بالتشريعات واحداً من الموارد الهامة التي يستعين بها واضعو النصوص المنخرطون في إعداد نصوص تشريعات تنفيذ الاتفاقية على الصعيد الوطني. وهي تتسم بثلاث مزايا رئيسية:

- (أ) أنها تتيح النفوذ سريعاً إلى مجموعة متزايدة من نماذج القوانين المعنية؛
- (ب) أنها تقلص عدد طلبات الدول الأطراف لقيام الأمانة باستنساخ نصوص نماذج القوانين المعنية وإرسالها إليها بالبريد؛
- (ج) أنها بالتالي توفر وقت العاملين وتقلص التكاليف.

٥- وتُشجّع الدول الأطراف الراغبة في المساهمة في قاعدة البيانات هذه على إرسال نص تشريعاتها في شكل إلكتروني إلى مكتب المستشار القانوني على العنوان legal@opcw.org.
