NOTE BY THE TECHNICAL SECRETARIAT

**ANNUAL DECLARATIONS ON PAST ACTIVITIES FOR 2007 AND 2008,
ON PROJECTED ACTIVITIES AND ANTICIPATED PRODUCTION IN 2009
AT SCHEDULE 1 FACILITIES, AND ON ANTICIPATED ACTIVITIES
AT SCHEDULE 2 AND 3 PLANT SITES IN 2009
AS AT 1 APRIL 2009**

1. According to Article VI, paragraph 8, of the Chemical Weapons Convention (hereinafter “the Convention”), each State Party “shall make annual declarations regarding the relevant chemicals and facilities in accordance with the Verification Annex”.
2. According to paragraph 8 of Article VI and Parts VI, VII, VIII, and IX of the Verification Annex to the Convention (hereinafter “the Verification Annex”), States Parties shall submit annual declarations on past activities (ADPAs) in relation to scheduled chemicals and related facilities, and each year shall submit the information necessary to update the list of other chemical production facilities not later than 90 days after the end of the previous calendar year.
3. The deadline for the submission of ADPAs for 2008 was thus 31 March 2009. However, as the Afghanistan Conference was being held on that day, the Technical Secretariat was unable to receive declarations on 31 March, and States Parties were requested to submit them on 1 April. The States Parties listed in Annex 1 had submitted their ADPAs by 1 April 2009.
4. Further to the information provided in S/689/2008, dated 11 April 2008, on the submission of the ADPAs for 2007, Annex 2 to the present Note lists the 83 States Parties (of the 182 that had joined the Convention by the end of 2007) that had submitted ADPAs for 2007 by 1 April 2009.
5. According to Part VI, paragraph 16, of the Verification Annex, each State Party producing Schedule 1 chemicals at a single small-scale facility “shall make a detailed annual declaration regarding the projected activities and the anticipated production at the facility for the coming year”. It further requires that the declaration be submitted “not less than 90 days before the beginning of that year”. In addition, paragraph 20 of Part VI requires the same of each State Party for each facility producing Schedule 1 chemicals in quantities not exceeding 10 kilograms per year for protective purposes,



or in quantities of more than 100 grams per year for medical, pharmaceutical, or research purposes.

6. Further to the information provided in S/713/2008, dated 10 October 2008, on the submission of annual declarations regarding projected activities and anticipated production in 2009, Annex 3 to the present Note lists the 27 States Parties (of the 185 as at 31 December 2008) that had submitted their declarations for 2009 by 1 April 2009.
7. According to Part VII, subparagraph 4(c), of the Verification Annex, each State Party shall submit annual declarations on anticipated activities (ADAAs) at Schedule 2 plant sites not later than 60 days before the beginning of the following calendar year, while Part VIII, subparagraph 4(c), requires the same of each State Party for plant sites producing Schedule 3 chemicals.
8. Further to the information provided in S/718/2008, dated 10 November 2008, on the submission of ADAAs for 2009, Annex 4 to the present Note lists the 48 States Parties (of the 185 as at the end of 2008) that had submitted ADAAs for 2009 by 1 April 2009.
