### NOTE BY THE TECHNICAL SECRETARIAT

## CALL FOR NOMINATIONS FOR THE SEVENTH REGIONAL MEETING OF NATIONAL AUTHORITIES OF STATES PARTIES IN AFRICA RABAT, MOROCCO 27 – 29 OCTOBER 2009

- 1. On behalf of the Government of Morocco and the Organisation for the Prohibition of Chemical Weapons (OPCW), the Director-General wishes to invite National Authorities to submit nominations for the Seventh Regional Meeting of National Authorities of States Parties in Africa, which will be held in Rabat, Morocco, from 27 to 29 October 2009.
- At its Eighth Session, the Conference of the States Parties (hereinafter "the 2. Conference") adopted a plan of action regarding the implementation of Article VII obligations (C-8/DEC.16, dated 24 October 2003), and at its Tenth Session adopted a decision on follow-up to that plan (C-10/DEC.16, dated 11 November 2005). At its Eleventh Session, the Conference adopted a decision on sustaining follow-up to the plan of action (C-11/DEC.4, dated 6 December 2006), in which the Technical Secretariat (hereinafter "the Secretariat") was requested "to continue and enhance its efforts to assist States Parties...to meet their obligations under Article VII". At its Twelfth Session, the Conference reiterated this request to assist States Parties with a view to addressing their practical national implementation issues and concerns regarding, inter alia, matters related to industry and trade (C-12/DEC.9, dated 9 November 2007). At its Thirteenth Session, the Conference adopted a decision (C-13/DEC.7, dated 5 December 2008) on the implementation of Article VII obligations, which recalled its earlier decision adopted at its Twelfth Session concerning follow-up to the plan of action (C-12/DEC.9).
- 3. The Second Special Session of the Conference of the States Parties to Review the Operation of the Chemical Weapons Convention also welcomed the efforts made by States Parties to assist each other, upon request, in their national implementation measures (RC-2/4, dated 18 April 2008). It further noted the value of bilateral assistance and networking within and among regions, especially for States Parties with limited resources who may need particular assistance.
- 4. In this context, this meeting will serve as a forum in which States Parties in the region can present their needs for assistance in relation to these obligations, and during

which they can also indicate what assistance they can offer to other States Parties. In addition, it will help the Secretariat determine how it can enhance the assistance it offers to States Parties in the region in the light of the aforementioned Conference decisions.

- 5. The meeting is also to serve as a forum in which representatives of National Authorities can confer with each other, with Secretariat staff, and with resource persons who have been invited to the meeting, in order to identify what further steps, if any, each State Party needs to take in order to implement its Article VII obligations.
- 6. The programme for the meeting includes the following items:
  - (a) a review of, and the sharing of best practices and lessons learnt in implementing them;
  - (b) a review of national requests for and offers of implementation support, with particular regard to the establishment and running of a National Authority and the drafting of implementing legislation;
  - (c) a review of the OPCW Programme to Strengthen Cooperation with Africa and discussions on how it may enhance the implementation of national obligations of States Parties in the region and promote regional and subregional collaboration:
  - (d) outreach to industry and identification of declarable industry;
  - (e) the provisions of the Chemical Weapons Convention (hereinafter "the Convention") regarding the trade in chemicals;
  - (f) implementation by National Authorities of the provisions on the import and export of scheduled chemicals;
  - (g) common problems in reporting imports and exports, and progress regarding solutions;
  - (h) recent developments regarding Article VI issues and their potential impact on Africa; and
  - (i) bilateral meetings with Secretariat staff.
- 7. Nominees should actually be involved in the national implementation of the Convention. Participants from each State Party represented at the meeting will be expected to make contributions to discussions and group exercises in each of the following areas:
  - (a) the status of implementation of the Convention in the State Party in question, including the designation or establishment of a National Authority and the current status of its national implementing legislation and/or administrative measures;

- (b) any problems encountered in these areas, and any support required to address them;
- (c) what offers of support, and in which areas of expertise, the State Party can make to other States Parties in the region/subregion, as well as any conditions for such offers, and the dates on which this support will be available;
- (d) an update on the practices undertaken by National Authorities to gather data on the import and export of scheduled chemicals;
- (e) efforts by National Authorities to implement the provisions of the Convention on matters related to trade and industry; and
- (f) what steps National Authorities are taking to engage relevant stakeholders and to sensitise them to the Convention.
- 8. The provisional programme for the meeting is included as Annex 1 to this Note.
- 9. The Secretariat expects to be able to sponsor the participation of a limited number of representatives of National Authorities and of those involved in drafting national implementing legislation. Each nomination should specify whether sponsorship is a condition of the nominee's participation. For sponsored participants, the Secretariat will cover the costs of travel, meals, and medical insurance, and will provide a limited subsistence allowance to cover sundry expenses. The Secretariat will also arrange and pay for accommodation for sponsored participants. Sponsored participants who do not intend to use the accommodation arranged by the Secretariat are requested to indicate that as soon as possible, so that the Secretariat does not incur hotel cancellation fees. In no case will the Secretariat cover the costs of any accommodation it has not arranged.
- 10. When making travel arrangements for sponsored participants, the Secretariat will seek the most economical options. It will purchase tickets and send them to participants. Participants will be allowed to purchase tickets locally only if this leads to further savings for the Secretariat and if the Secretariat authorises it. In order for the Secretariat to keep costs to a minimum, participants are expected to arrive **no earlier** than Monday, **26** October 2009 and depart to no later than Friday, 30 October 2009. The Secretariat's agreement is required for any changes to the arrival and departure dates. The Secretariat will not cover expenses unrelated to the meeting or that result from changes to travel arrangements it has not authorised. Sponsored participants shall bear all costs resulting from changes they make, including cancellations, once the Secretariat has purchased tickets. Participants who have not been sponsored are requested to make their own travel and accommodation arrangements, although the Secretariat can, if necessary, arrange accommodation at reduced rates.
- 11. Participants are requested to obtain any necessary visas (including transit visas) before travelling to Morocco. When applying for any entry visa, they should present the Embassy or Consulate of Morocco with a copy of the acceptance letter from the OPCW.

- 12. All activities during the meeting will be conducted in English, with interpretation into French. All participants are therefore expected to have a good written and oral command of one of these languages.
- 13. Interested National Authorities are invited to complete the nomination form that is included as Annex 2 to this Note, making sure in particular to provide all the contact details it requests. All nominations must be received by the Secretariat **no later than Friday, 25 September 2009**. Nominations received by the Secretariat after the deadline will not be considered for sponsorship. Please be advised that participants must present an OPCW acceptance letter in order to register at the meeting.
