# NOTE BY THE TECHNICAL SECRETARIAT

## INVITATION TO APPLY FOR AN ANALYTICAL-SKILLS TRAINING COURSE KYIV, UKRAINE 6 – 11 JUNE 2011

## **Purpose of the course**

- 1. The Technical Secretariat (hereinafter "the Secretariat") wishes to inform Member States that, with its support, the Taras Shevchenko National University of Kyiv, Ukraine, will be organising an analytical-skills training course **for Russian-speaking participants**. The course will be held at the Department of Analytical Chemistry at Taras Shevchenko National University from 6 to 11 June 2011.
- 2. The course is intended for chemistry professionals from industry, government, or academia who are involved in the analysis, synthesis, or quality control of chemicals related to the Chemical Weapons Convention (hereinafter "the Convention"). The course will enable participants to gain a sound working knowledge of the principles, procedures, and applications of gas chromatography (GC), gas chromatography-mass spectrometry (GC-MS), and other hyphenated GC-MS analytical techniques for the analysis of chemicals related to the Convention. The course will accommodate 12 participants.

### Content of the course

- 3. The course will cover basic training and hands-on experience in sample preparation and GC and GC-MS analysis of chemicals related to the Convention. It will also include an explanation of the hardware involved, method optimisation, basic maintenance, and trouble-shooting. The participants will be provided with intensive hands-on training in the handling of different sample matrices for subsequent analysis by GC with flame-ionisation detectors and by GC-MS in electron ionisation mode.
- 4. In particular, the course will provide information and training on sample-preparation techniques, such as solid phase extraction and derivatisation. The topics related to GC will include lectures on columns and conditions, injectors, sample introduction, detectors, qualitative and quantitative analysis, and trouble shooting and maintenance. Courses and exercises relating to GC-MS will include the MS fragmentation pattern of compounds related to the Convention, and the processing of GC-MS data. Finally,

the course will include a session on sensors for the quick detection of chemicals related to the Convention.

## Sponsorship

- 5. The cost of the course, and of accommodation for all participants will be covered by the Secretariat. In addition, the Secretariat will pay for international travel, visas, the provision of a daily subsistence allowance (DSA), and medical and travel insurance for all participants for the duration of the course.
- 6. Participants are requested to obtain any necessary visas, including travel visas, before travelling to Ukraine. As noted above, the Secretariat will cover the costs of these visas by reimbursing participants upon production of the original receipts. The Secretariat will also send information to the selected participants on applying for Ukrainian visas.

### **Admission requirements**

- 7. Participants should:
  - (a) hold a degree or diploma in chemistry or analytical chemistry from a recognised university or institution;
  - (b) have at least three years of work experience in analytical chemistry or in other relevant fields;
  - (c) have experience working with either GC or GC-MS techniques; and
  - (d) be citizens of a Member State.
- 8. All course activities will be conducted in Russian, and no interpretation services of any kind will be provided. Participants are therefore expected to have a good command of the Russian language, both written and oral.
- 9. Participants will be required to sign both a set of terms and conditions for participation in the course and a confidentiality agreement with the OPCW.

## Selection procedure

10. Applications will be carefully screened on the basis of the criteria specified in paragraph 7 above. Only the most suitable applicants will be interviewed. Eligible candidates from laboratories that have sought or are receiving support under the Laboratory-Assistance Programme are especially encouraged to apply.

### **Application procedure**

11. Applicants from laboratories in Member States are invited to complete the application form that is included as the annex to this Note, making sure in particular to provide all the contact details it requests. To facilitate communication with the Secretariat and with the Taras Shevchenko National University of Kyiv, each applicant must provide

an e-mail address or a fax number. The completed form, <u>together with a curriculum</u> <u>vitae and a recommendation from the National Authority or the Permanent</u> <u>Representation of the applicant's country</u>, should sent to the Head, International Cooperation Branch, International Cooperation and Assistance Division, OPCW, Johan de Wittlaan 32, 2517 JR The Hague, the Netherlands.
