NOTE BY THE TECHNICAL SECRETARIAT

**THE INTERNATIONAL MEETING ON CHEMICAL SAFETY AND SECURITY
TARNÓW, POLAND
8 AND 9 NOVEMBER 2012**

1. On behalf of the Government of Poland and the Organisation for the Prohibition of Chemical Weapons (OPCW), the Technical Secretariat (hereinafter “the Secretariat”) wishes to invite States Parties, governmental agencies, international organisations, chemical industries and its trade associations, laboratories, academia, and non-governmental organisations (NGOs) to the upcoming international meeting on chemical safety and security, which will take place on 8 and 9 November 2012 in Tarnów, Poland.
2. The meeting is organised in cooperation with the G8 Global Partnership and other international partners. Financial support is being provided under the European Union (EU) Council Decision 2012 in support of activities of the OPCW in the framework of the implementation of the EU Strategy against Proliferation of Weapons of Mass Destruction (2012/166/CFSP, dated 23 March 2012), the United States Chemical Security Engagement Programme, and the Government of Poland.
3. The meeting aims to encourage international cooperation in the field of chemical safety and security and promote the development of a global chemical safety-and-security culture. It will seek ways to enhance chemical safety and security at the national level, support capacity building, exchanges of best practices, and improve national and international coordination in these matters.
4. The meeting will be attended by representatives of States, governmental agencies, international organisations, chemical industries, and academia, and will provide an opportunity for them to explore national and international approaches and innovative strategies in chemical safety and security.
5. The relevant background documentation for the meeting, including the nomination form, is also available on the OPCW website.

Background

6. The global chemical industry and its activities have grown rapidly over the past several decades and continue to expand. Applying sound principles for chemical



safety and security is consequently becoming critically important for an increasing number of States. Promoting and establishing a global chemical safety-and-security culture will provide greater assurances that national measures undertaken in this regard can prevent the misuse of toxic chemicals.

7. The OPCW's involvement in regard to enhancing chemical safety and security is a follow-up to the decisions of both the First Special Conference of the States Parties to Review the Operation of the Chemical Weapons Convention and the Second Special Session of the Conference of the States Parties to Review the Operation of the Chemical Weapons Convention (hereinafter "the Second Review Conference"), held in 2003 and 2008, respectively. The Second Review Conference welcomed the fact that some States Parties had taken measures to minimise security risks at chemical facilities and encouraged States Parties to exchange experiences and discuss related issues (paragraph 9.94 of RC-2/4, dated 18 April 2008).
8. The Conference of the States Parties decided (C-16/DEC.10, dated 1 December 2011)¹ at its Sixteenth Session that, inter alia, a series of measures concerning chemical safety and security should be implemented.
9. The subsequent discussions and activities of the Member States and the Secretariat have further developed the OPCW as a platform of support for global cooperation in decreasing the chemical threat, and includes such activities as raising awareness, training, the exchange of best practices, and fostering cooperation between chemical professionals in order to support the safe and secure production, transportation, and storage of chemicals. These activities have included the "Seminar on OPCW's Contribution to Security and Non-Proliferation of Chemical Weapons", held in The Hague, the Netherlands (OPCW Headquarters building), on 11 and 12 April 2011; and the Conference on International Cooperation and Chemical Safety and Security, held in The Hague, the Netherlands (OPCW Headquarters building), on 12 and 13 September 2012.

Meeting objectives

10. The meeting is another step in promoting the OPCW as a platform of support for global cooperation in decreasing the chemical threat and enhancing chemical safety and security.
11. The Tarnów meeting will involve a broad coverage of all issues relevant to chemical safety and security. Discussions and presentations include topics such as national measures and approaches, international cooperation and assistance, chemical-industry issues, and chemical plant and transportation security.
12. Meeting objectives will include the following:
 - (a) promoting a global chemical safety-and-security culture and international cooperation in that field;
 - (b) strengthening the commitment to develop a global chemical safety-and-security culture;

- (c) fostering discussions on effective responses to the misuse of chemicals;
- (d) exchanging ideas on the evolving nature of the chemical industry;
- (e) building synergies and strengthening collaborative frameworks between governments, international organisations, chemical industry, academia, and NGOs;
- (f) raising awareness about assistance needs in the areas of chemical safety and security and the transportation of chemicals, including in countries with emerging economies; and
- (g) encouraging discussion on the role that international organisations can play in developing security mechanisms in a changing environment.

13. The meeting is expected to achieve the following results:

- (a) to raise awareness of and promote the exchange of ideas and expertise on global chemical safety and security;
- (b) to support global cooperation in lessening the chemical threat by promoting awareness of chemical-security best practices and fostering cooperation between chemical professionals;
- (c) to offer assistance in enhancing national measures in the areas of the chemical safety and security and the transportation of chemicals; and
- (d) to highlight chemical weapons proliferation as a global threat that requires a global response and to discuss how to effectively respond to this threat.

Venue and dates

14. The two-day meeting will be held in Tarnów, Poland, at the Tarnów Theatre (Adama Mickiewicza 4, 33-100 Tarnów, Poland) on 8 and 9 November 2012.

Format

15. The meeting will be inaugurated by a high-level opening plenary session and possible adoption of a declaration on the importance of developing a global chemical-safety-and-security culture; this will be followed by three working sessions. The final session will provide an opportunity for the outcomes to be discussed.

Participants

16. Key stakeholders and target audiences for the meeting include representatives from governments, relevant national agencies, international organisations engaged in the field of chemical safety and security, the chemical industry and its trade associations, academia, laboratories, NGOs, and independent experts.

Registration, sponsorship, coordination, contact information, and logistical information

17. Those wishing to participate in the meeting are invited to complete the nomination form that is annexed hereto, and which can also be downloaded from the OPCW website (www.opcw.org). Every participant will receive a letter of confirmation from the Secretariat.
18. 19. The meeting will be conducted in English. All participants are therefore expected to have a good oral and written knowledge of this language.
20. If indicated on the nomination form, the Secretariat will reserve hotel accommodation on behalf of the participant. Unless sponsored by the OPCW, the participant is expected to pay in full for hotel accommodation.
21. Participants are requested to obtain all necessary visas (including transit visas) before travelling to Poland.

Sponsorship

22. Due to the limited funds available for sponsorship, the Secretariat expects to be able to sponsor only a limited number of participants from States Parties. The nomination of qualified female participants is strongly encouraged. Each nomination should specify whether sponsorship is a condition for the nominee's participation. For sponsored participants, the Secretariat will cover the costs of travel and medical insurance, as well as hotel and meals and will provide a daily subsistence allowance to cover sundry expenses.
23. When making travel arrangements for sponsored participants, the Secretariat will seek the most economical options. The Secretariat will purchase tickets and send them to participants. Sponsored participants shall bear all costs resulting from any changes they make, once the Secretariat has purchased tickets. In order for the Secretariat to keep costs to a minimum, sponsored participants are expected to arrive in Tarnów, Poland, **no earlier than Wednesday, 7 November 2012**, and to depart **no later than Friday, 9 November 2012**. The Secretariat's approval is required for any changes to the arrival and departure dates of sponsored participants. The Secretariat will not cover expenses unrelated to the course or that result from changes in travel

arrangements that it has not authorised. Sponsored participants shall bear all costs resulting from changes they make, including cancellations, once the Secretariat has purchased their tickets.
