NOTE BY THE TECHNICAL SECRETARIAT**SUBMISSION OF ANNUAL DECLARATIONS ON PAST ACTIVITIES FOR 2013 AND 2014, ON PROJECTED ACTIVITIES AND ANTICIPATED PRODUCTION IN 2015 AT SCHEDULE 1 FACILITIES, AND ON ANTICIPATED ACTIVITIES AT SCHEDULE 2 AND 3 PLANT SITES IN 2015 AS AT 31 MARCH 2015**

1. According to paragraph 8 of Article VI of the Chemical Weapons Convention (hereinafter “the Convention”), “[e]ach State Party shall make annual declarations regarding the relevant chemicals and facilities in accordance with the Verification Annex”.
2. According to paragraph 8 of Article VI and Parts VI, VII, VIII, and IX of the Verification Annex to the Convention (hereinafter “the Verification Annex”), States Parties shall submit annual declarations on past activities (ADPAs) in relation to scheduled chemicals and related facilities, and each year shall submit the information necessary to update the list of other chemical production facilities not later than 90 days after the end of the previous calendar year.
3. The deadline for the submission of ADPAs for 2014 was thus 31 March 2015. Annex 1 lists the 75 States Parties with declarable activities, as well as the four States Parties with nil declarations that submitted their ADPAs by that deadline. There has been an increase of four States Parties with declarable activities that have submitted their declarations on time compared to last year, when 71 States Parties with declarable activities, as well as seven States Parties with nil declarations, submitted their ADPAs by the deadline.
4. In addition, for the ADPAs for 2013, 20 States Parties with declarable activities submitted their ADPAs after the deadline of 31 March 2014. Eleven out of those 20 States Parties submitted their declarations more than 30 days after the deadline. Further to the information provided in S/1173/2014 (dated, 15 April 2014), Annex 2 lists the 91 States Parties with declarable activities, as well as 11 States Parties with nil declarations, that submitted their ADPAs for 2013 by 31 March 2015.
5. As for Schedule 1, according to paragraph 16 of Part VI of the Verification Annex, “[e]ach State Party producing Schedule 1 chemicals at a single small-scale facility shall make a detailed annual declaration regarding the projected activities and the anticipated production at the facility for the coming year”. It further requires that the declaration “shall be submitted not less than 90 days before the beginning of that year”. In addition, paragraph 20 of Part VI of the Verification Annex requires the



same of each State Party producing Schedule 1 chemicals at other facilities referred to in paragraphs 10 and 11 of Part VI of the Verification Annex.

6. Four States Parties provided their annual declarations regarding projected activities and anticipated production at Schedule 1 facilities for 2015 after the deadline of 2 October 2014. One additional State Party submitted an amendment to its initial declaration for a new Schedule 1 facility on 11 November 2014. Further to the information provided in S/1218/2014 (dated, 8 October 2014) Annex 3 lists the 23 States Parties with projected activities and anticipated production at Schedule 1 facilities, as well as the six States Parties with nil declarations that submitted their declaration for 2015 by 31 March 2015.
7. As for annual declarations on anticipated activities (ADAAs), according to subparagraph 4(c) of Part VII of the Verification Annex, each State Party shall submit ADAAs at Schedule 2 plant sites not later than 60 days before the beginning of the following calendar year, while subparagraph 4(c) of Part VIII requires the same of each State Party for plant sites producing Schedule 3 chemicals.
8. Six States Parties with declarable activities submitted their ADAA for 2015 at Schedule 2 and/or for Schedule 3 plant sites after the deadline of 1 November 2014. One out of those six States Parties submitted its declaration more than 30 days after the deadline. Further to the information provided in S/1223/2014 (dated, 13 November 2014), Annex 4 lists the 44 States Parties with declarable activities, in addition to the nine States Parties with nil declarations that submitted ADAAs for 2015 at Schedule 2 and 3 plant sites by 31 March 2015.
