NOTE BY THE DIRECTOR-GENERAL

TENTATIVE SCHEDULE FOR OFFICIAL OPCW PROFICIENCY TESTS IN 2016 AND 2017

- 1. The Director-General wishes to inform Member States of the tentative schedule for official OPCW proficiency tests in both 2016 and 2017.
- 2. A new proficiency testing programme for the analysis of biomedical samples will start in 2016. This new programme is in addition to the two traditional proficiency tests that have led to the designation of laboratories for off-site analysis of environmental samples. These two programmes are separate, and laboratories are welcome to participate in either or both programmes.
- 3. Both proficiency testing programmes may be conducted with the assistance of designated laboratories. The tables that follow indicate the laboratories and Member States that have volunteered to assist the Technical Secretariat (hereinafter "the Secretariat") with the proficiency test. If the "Assisting Laboratory" column is blank, the Secretariat would welcome designated laboratories to volunteer.
- 4. Prior to each proficiency test, the Secretariat will issue an official Note announcing the test with instructions on how to participate.
- 5. The tentative test schedule and the laboratories that will be assisting are listed in the following two tables.

The Conference of the States Parties at its Twentieth Session adopted a decision entitled "Designation of Laboratories for the Analysis of Authentic Biomedical Samples and Guidelines for the Conduct of Biomedical Proficiency Tests" (C-20/DEC.5, dated 2 December 2015) establishing a proficiency testing programme for biomedical sample analysis.
