NOTE BY THE TECHNICAL SECRETARIAT

SUBMISSION OF ANNUAL DECLARATIONS ON PAST ACTIVITIES IN 2014 AND 2015, ON PROJECTED ACTIVITIES AND ANTICIPATED PRODUCTION FOR 2016 AT SCHEDULE 1 FACILITIES, AND ON ANTICIPATED ACTIVITIES AT SCHEDULE 2 AND SCHEDULE 3 PLANT SITES FOR 2016 AS AT 30 MARCH 2016

- 1. According to paragraph 8 of Article VI of the Chemical Weapons Convention (hereinafter "the Convention"), "[e]ach State Party shall make annual declarations regarding the relevant chemicals and facilities in accordance with the Verification Annex".
- 2. According to paragraph 8 of Article VI and Parts VI, VII, VIII, and IX of the Verification Annex to the Convention (hereinafter "the Verification Annex"), States Parties shall submit annual declarations on past activities (ADPAs) in relation to scheduled chemicals and related facilities, and each year shall submit the information necessary to update the list of other chemical production facilities not later than 90 days after the end of the previous calendar year.
- 3. The deadline for the submission of ADPAs for 2015 was thus 30 March 2016. Annex 1 lists the 79 States Parties with declarable activities plus the three States Parties with nil declarations that submitted their ADPAs by that deadline. There has been an increase of four States Parties with declarable activities that have made their submissions on time, compared to last year when 75 States Parties with declarable activities plus four States Parties with nil declarations submitted their ADPAs by the deadline.
- 4. In terms of the electronic transmission of declarations, the Secure Information Exchange (SIX) system was used by 30 of the 79 States Parties that submitted ADPA 2015 on time. This represents a 100% increase when compared to last year, when 15 States Parties used SIX to submit their declarations.
- 5. In addition, for ADPA 2014, 15 States Parties with declarable activities submitted their ADPAs after the deadline of 31 March 2015. Three of those 15 States Parties made their submissions more than 30 days after the deadline. Further to the information provided in S/1268/2015 (dated 23 April 2015), Annex 2 lists the

90 States Parties with declarable activities plus the 10 States Parties with nil declarations that submitted their ADPAs for 2014 by 30 March 2016.

- 6. As for Schedule 1, according to paragraph 16 of Part VI of the Verification Annex, "[e]ach State Party producing Schedule 1 chemicals at a single small-scale facility shall make a detailed annual declaration regarding the projected activities and the anticipated production at the facility for the coming year". It further requires that the declaration "shall be submitted not less than 90 days before the beginning of that year". In addition, paragraph 20 of Part VI of the Verification Annex requires the same of each State Party producing Schedule 1 chemicals at other facilities referred to in paragraphs 10 and 11 of Part VI of the Verification Annex.
- 7. Two States Parties provided their annual declarations regarding projected activities and anticipated production at Schedule 1 facilities for 2016 after the deadline of 2 October 2015. Further to the information provided in S/1314/2015 (dated 9 October 2015), Annex 3 lists the 23 States Parties with projected activities and anticipated production at Schedule 1 facilities plus the 16 States Parties with nil declarations that submitted their declarations for 2016 by 30 March 2016.
- 8. As for annual declarations on anticipated activities (ADAAs), according to subparagraph 4(c) of Part VII of the Verification Annex, each State Party shall submit ADAAs at Schedule 2 plant sites not later than 60 days before the beginning of the following calendar year, while subparagraph 4(c) of Part VIII requires the same of each State Party for plant sites producing Schedule 3 chemicals.
- 9. Two States Parties with declarable activities submitted their ADAA for 2016 for Schedule 2 and/or Schedule 3 plant sites after the deadline of 1 November 2015. Further to the information provided in S/1328/2015 (dated 13 November 2015), Annex 4 lists the 46 States Parties with declarable activities plus the 19 States Parties with nil declarations that submitted ADAAs for 2016 at Schedule 2 and Schedule 3 facilities by 30 March 2016.
