NOTE BY THE DIRECTOR-GENERAL

**TENTATIVE SCHEDULE FOR OFFICIAL OPCW
PROFICIENCY TESTS IN 2018 AND 2019**

1. The Director-General wishes to inform Member States of the tentative schedule for official OPCW proficiency tests in both 2018 and 2019.
2. The Technical Secretariat (hereinafter “the Secretariat”) organises two different proficiency tests—one for environmental samples (PT) and the other for biomedical samples (BioPT). These two programmes are separate, and laboratories are welcome to participate in one or both of them.
3. Both proficiency testing programmes may be conducted with the assistance of designated laboratories. The tables that follow indicate the laboratories and Member States that have volunteered to assist the Secretariat with the proficiency test. If the “Assisting Laboratory” column is blank, the Secretariat would welcome designated laboratories to volunteer.
4. Prior to each proficiency test, the Secretariat will issue an official Note announcing the test with instructions on how to participate. For further information regarding these tests please contact the Secretariat by email (proficiency@opcw.org).
5. The tentative test schedule and the laboratories that will be assisting are listed in the following two tables attached in annex.
